

# 2026 FINANCIAL POLICIES

Camper registration opens January 6, 2026 for returning families and January 13, 2026 community-wide. Space is limited.

**Please read closely as our financial policies have changed in 2026.**

## DEPOSIT

A non-refundable deposit of \$100 per session is due at the time of registration.

This deposit will be applied toward your total camp fees. A credit card is required at the time of registration to make your deposit.

Registrations will not be accepted without the deposit and a payment method for the balance of the camp fees in place.

**Please Note:** Registrations will be processed and accepted on a first come, first served basis. You will receive a confirmation email confirming your registration upon completion.

If additional information is required to complete your registration process, the Minnesota JCC will contact you directly.

## PAYMENT OPTIONS

A non-refundable deposit of \$100 per session is due at the time of registration.

You can choose from the following two options to complete your balance of payments:

- 1) Payment in full at time of application by credit card.
- 2) Deposit of \$100 per session at time of registration. Remaining balance per session will be auto-billed to your payment method on file 120 days before the start date of the corresponding session.

*Example: Sessions starting on June 15 will be auto-billed for remaining balance on February 15. Sessions that begin on August 24 will be auto-billed for remaining balance on April 26.*  
Reference the table below to see all session start dates and corresponding billing dates

- 3) If you register for a session *AFTER* the designated billing date (120 days before the beginning of the session) you will be prompted to pay in full for the session. If this creates financial concern, contact the JCC Business office at [businessoffice@minnesotajcc.org](mailto:businessoffice@minnesotajcc.org)
- 4) Any remaining balances will be auto-billed to your payment method on file no later than June 1.

## 2026 Camp Billing Dates

- 1) If you choose to, you may pay in full at time of registration.
- 2) If you do not pay in full at time of registration, your per session non-refundable deposit will be \$100/session. Billing dates for your remaining camp tuition are 120 days before the start of each registered session and will be automatically billed to your payment method on file. Following is the schedule of billing dates and corresponding session start dates:

## WAITING LIST

Camp Butwin and Camp Olami will maintain a waiting list for each program session as it fills. Our staff will contact families as space becomes available.

Waiting lists are maintained based on date of registration. Entry on a waiting list does not guarantee placement.

*There is no fee associated with any waiting list.*

## TUITION BENEFITS FOR JCC MEMBERS

Members of the MN JCC are eligible for deeply discounted rates for summer camp programs. To qualify for the member discount, campers must be current JCC members as part of a membership attached to a custodial adult/legal guardian/parent from time of registration through the completion of the summer camp season (September 1, 2026).

## **FINANCIAL ASSISTANCE**

The Minnesota JCC believes that camping experiences are incredibly valuable for all children. It is our hope that financial need is not a barrier to any child's participation, and we encourage families to apply for financial assistance from all available sources.

### **Scholarships through the Minnesota JCC:**

Minnesota JCC members may apply for scholarships directly through the Minnesota JCC.

Scholarship applications are reviewed and awarded on a rolling basis. The review period is 1-2 weeks from the date the complete scholarship application is received.

Due to high need in the community, families are highly encouraged to explore all eligible scholarship funding sources, including sources external to the JCC.

Families are encouraged to submit their completed applications promptly.

# 2026 FINANCIAL POLICIES

## **Adjusted Payment Timeline:**

Families may request an alternate payment plan to alleviate financial hardship by contacting the Minnesota JCC Business office by email at [businessoffice@minnesotajcc.org](mailto:businessoffice@minnesotajcc.org) to discuss a modified payment plan. All camp tuition must be paid no later than September 1, 2026.

## **CANCELLATION AND REFUND POLICIES**

A non-refundable deposit of \$100 per session is required at the time of registration. If you wish to cancel your registration:

- 1) If your cancellation is received in writing by 11:59 PM on April 15, you are eligible for a full refund less your deposit.
- 2) Between April 16 and 11:59 PM on May 15, you are eligible for a 50% refund.
- 3) After May 15, 2024, there will be no refunds for cancellations, including additional options such as (but not limited to) after camp care, camp lunch, etc.

*Minnesota JCC Day Camps do not pro-rate for missed camp days.*
